NOTICE OF RACE

Event: 2010 SPRING KEELBOAT SERIES

Dates: 13 March, 10 April 2010, 8 May 2010

Host: Lake Canyon Yacht Club, Canyon Lake

Eligibility: Each entrant must be a member in good standing of an area yacht club which is a member of US SAILING.

Rules: This regatta will be governed by the Racing Rules of Sailing (RRS) 2009-2012, the prescriptions of the US Sailing Association (USSA), this Notice (except as any of these are modified by the sailing instruction), the current version of the Canyon Lake sailing instructions, and if sailing in a one design fleet, the applicable class rules. This event is classified as a category "A" event. Any additional information will be posted on the official notice window of the clubhouse.

Registration: Only boats with paid registrations and entries registered online shall race. You may register online from home or from the clubhouse computer for the series race, prior to the end of late registration, or for any single race on the day of the race, prior to the RC leaving the dock. You must race in the class that you register for throughout the series.

Scoring: Low point system as outlined in Appendix A2.2 and A5 (i.e. - 1st place = 1, 2nd = 2, 3rd = 3, 4th = 4, etc.) Single day racers will not be scored in the series results, but their actual finishing positions will be recognized in the race report.

Proposed Classes: J-22, Catalina 22, PHRF Spinnaker, PHRF Non-spinnaker, PHRF Cruiser, PHRF Novice, and Corsair. Three (3) boats of a class or similar PHRF rating may constitute a fleet. Actual fleets will be set and announced at the Skippers Meeting. No fleets will be formed after the Skippers' Meeting.

Races and Courses: Two scheduled (2) races each Saturday, for a total of six (6) races. The best four (4) races, counted from the last race to the first, for each boat will determine final standing. The course for each race will be posted on the stern of the committee boat before each race. The course for each race shall be at the discretion of the Race Committee. The start will occur in the main Canyon Lake basin in front of LCYC. At the discretion of the principal race officer, the starting area may be changed to provide a fairer competition. If there is no visible wind on the lake at 12:00pm, the Race Committee may signal postponement on shore. Postponement will be communicated via VHF channel 68 and phone call to the Hill Country Yacht Club. All sailors are welcome to dock and enjoy the facilities at LCYC while waiting for the breeze to fill in.

Trophies: 3 to 4 boats = 1 trophy; 5 to 7 = 2; 8 to 9 = 3; 10 to 13 = 4; 14 to 16 = 5; 17 to 19 = 6; 20 and over = 7. Size of fleet for determining number of trophies will be based upon number of paid registrations as of 13 March 2010.

Refreshments: Beer, soda & snacks, 13 March & 10 April.
Dinner - 8 May 2010 - trophies to follow.
